Recipient of the Fulbright Scholarship for 2005 - 2006 granting a

Lecturing/Research award in Entrepreneurship – Presentation of this award was a result of my work on entrepreneurship in the former Soviet Union. The central theme of my essay was an exhaustive study in which several important issues were raised about the involvement of the United States government in the transitional economies of the world. This paper was submitted to the Fulbright organization for consideration in the Fulbright competition. After many months of deliberation, the organization decided that my work deserved recognition and the award was presented. I had originally requested Russia as my location, but after studying the economy of Kazakhstan and discovering that its needs were greater than Russia, I agreed to go there instead. My tenure in Kazakhstan was excellent. I was able to instruct at The Kazakhstan Institute of Management, Economics and Strategic Research. My classes in the Master of Business Administration program included Entrepreneurship and Decision Making.

Recipient of the Faculty Seminole Award - I was presented the Seminole Award in 2012. According to the FSU website, this award is presented to a faculty member who is responsible for major contributions to the University through service to students. This award is presented to those candidates who have an exemplary attitude toward students, who are enthusiastic about working with students, and who extend themselves to help students. This award is based on service beyond the responsibilities of their job description, teaching, and research. Instructors are nominated by students.

Recipient of the International McKeachie Teaching Award – I was awarded the Bill and Ginny McKeachie Award through the Improving University Teaching Conference for my paper titled " College Student Metamorphosis: What Can Instructors Do to Keep Up?". The award included a grant of \$1,650.

Recipient of the Dempsey Barron Leadership Award – I am proud to have received recognition by the Deans and an alumni board at Florida State University. Presentation of the award occurs only when a student exemplifies the leadership traits that set the recipient apart from the average college student. The following is an excerpt from the May 2004, Torch, the student newspaper for the Panama City campus of Florida State University. "There are not many people who would become a successful entrepreneur, retire and then return to school with the goal of obtaining a doctoral degree. However, College of Business student James Dever is doing just that. This type of determination and drive is what earned him the Dempsey Barron Award at this year's Graduation Banquet. Four years ago, an award was initiated in honor of the late Senator Dempsey Barron to recognize students displaying outstanding leadership skills while at FSU Panama City.... Jim Dever sets a high standard of commitment and hard work for others to emulate," stated Dean Ed Wright. "He has been an exceptional student and leader, always seeking to do his best while also helping others.... While a student at FSU Panama City, Dever organized the Society for Advancement of Management, started student study groups, assisted with homecoming activities, founded a mentoring program, and continues as the director of a student focused lecture series, which he implemented."

Outstanding Graduate – I received the award for Outstanding Graduate with the highest academic average in the School of Business during the graduation ceremony at Florida State University, Panama City Campus.

Who's Who Among Students in American Universities and Colleges – I received this award based on work with my fellow students in need of additional help in their studies and the diligence I displayed in ensuring their success.

Society for Advancement of Management International Competition – Each year at the international convention of the Society for the Advancement of Management, the Thomas Greensmith Case Competition is held. In 2004, it was in Baltimore, MD and my presentation was a study of the Glaxo Smith Kline Pharmaceutical Company and the company's efforts to restrict cross border pharmaceutical sales in Canada. This is a competition in which management students from around the world compete in an aggressive presentation of a timely case study. This was the first time that anyone from Florida State University had competed. My presentation placed third out of 28 college and university teams chosen to compete.

Highlights of my educational career

After discontinuing my college education in 1972, in order to become a business owner, I returned to school in 1999 at the age of 50, having to start over by attending community college. Upon obtaining my AA degree from Gulf Coast Community College, I was able to attend Florida State University where I received my bachelor's degree and then went on to finish the MBA program. On July 10, 2009, I received my Doctor of Philosophy degree in entrepreneurship from the University of Strathclyde in Glasgow, Scotland.

It was while I was studying in the MBA program that I was presented the Fulbright Scholars award based on my work with entrepreneurship and capitalism in the former Soviet Union. I was asked to complete my Fulbright in Almaty, Kazakhstan, where I was able to continue my studies of post-communist entrepreneurship and work directly with business owners in and around Almaty who were in need of assistance in trying to overcome the long lasting effects of communism. Also, during my master's program I created a summer entrepreneurial program for college and high school students to learn about and experience the thrill of business ownership. The program was an overwhelming success, but due to circumstances beyond my control, we were only able to provide the program for one year.

One of the highlights of my educational career is my current work with various entrepreneurship programs through the USO, Syracuse University, and the U.S. Small Business Administration. EBV (The Entrepreneurship Bootcamp for Disabled Veterans is presented by only eight universities in the US works with disabled returning veterans), VWISE (instruction to retired female veterans attempting to start their own company), OPERATION JUMP START (Sponsored by the USO, teaching active duty military, soon to be discharged, how to take their ideas to reality), BOOTS TO BUSINESS (Sponsored by the U.S. Small Business Administration, teaching active duty military idea development). Much of this work is voluntary but the rewards are immeasurable.

I attribute my success in education to my twenty year entrepreneurial career as well as my recently completed education. I have been able to blend experiential, philosophical, and theoretical instruction into my classes and the result has been overwhelming. In addition to the classroom, I serve on the Florida State University College of Business, Management Department Curriculum Committee. I have played a major role in the development of an entirely new entrepreneurial program for our university. I am responsible for one of the new courses in which students ideate, create, and operate their own company. The 2009 class succeeded in opening seven companies, four of which are still in operation. The 2012 class with which I am currently working has created and is operating thirteen companies, all of which are still operating. Funding is provided for the companies by the Jim Moran Institute for Global Entrepreneurship and students are expected to repay their startup funding with excess profits being donated to charity.

Another program I am also personally responsible for is the Chempreneurs. I am the sole business professor and am responsible for all aspects of the program from instruction, to creation of the student's final commercialization plans. This is a program that began in August 2009. Undergraduate students from the College of Business are matched, one-onone with a professor from the hard sciences, and his or her PhD student, in order for my student to investigate the feasibility to commercialize the technology created by the science professor. The program began with the College of Business and the Chemistry Department, and has now expanded to include the Arts Department. Two companies have been created as a result of this program.

Biography of my business career

It is difficult to determine exactly when my entrepreneurial career began, but my first "official" business was a lawn mower repair shop I established in my mother's garage at the age of ten. It remained in operation until I was old enough to work a regular job. During high school, I worked until midnight pressing trousers at a garment manufacturing company and I left college early to work for Standard Oil Company as a sales representative. The desire to be an entrepreneur beckoned at an early age and I quit Standard Oil and opened a service station with my wife, Fay. We operated it successfully until we amassed enough capital to make a down payment on the Sea Lodge Motel in Panama City Beach, Florida, in 1976, a small, 34-unit motel located directly on the Gulf of Mexico.

In 1979, my brother-in-law and I started a trucking company Dixie Transport, starting with four leased trailers and two rented semi-tractors, the company ultimately grew to include 85 semi-tractors, an office complex in Hattiesburg, Mississippi, complete with a repair shop and transfer facilities. We operated in all 48 contiguous states. In 1982, we started another trucking company, Golden Eagle Express. This company hauled commodities the vans owned by Dixie Transport were unable to haul. Fay and I then purchased the Herrington House Restaurant, a steak and seafood restaurant catering to the upscale diner. I spent my days at the trucking companies and managed the restaurant at night with great success. I set my sights on opening yet another restaurant. We purchased a building located in a 10 acre plot of woods and created Cane Creek Seafood, a buffet-style seafood restaurant, which was successful from day one. When I sold it in 1990, we were serving over 400 people each day.

In 1987, I purchased a failed motel in Hattiesburg, Mississippi, from a New York savings and loan company. The previous owners of this business had allowed the property to deteriorate to a point the buildings were in extreme disarray. Immediately, we began to refurbish the buildings and opened it as a Quality Inn, a 150-unit property with banquet facilities, lounge, and restaurant. Business increased quickly, despite extreme competition, and when I sold the Quality Inn in 1990, I had raised the average daily rate from \$21.50 a night to \$37.90 with an increase in occupancy to over 66%. We had once again been successful.

There were other businesses I owned through the years that were of an ancillary nature. Beach TV was a television repair shop I opened in 1983, which became the number one television sales and service company on Panama City Beach, Florida, before I sold it. Gulf Sheetrock Company began operating during a sheetrock shortage in 1982 to ensure the successful completion of homes that my construction company was building. All of these ventures were successful.

My lifelong dream, beginning as a child upon the death of my father at age 42, was to be able to retire at an early age and "see the world". In 1991, at the age of 41, I achieved that goal by selling my remaining businesses. Our children were at a place in their lives where Fay and I could start traveling. We have traveled to six of the seven continents and even started a travel agency in 1993 to further accommodate our "travel desires".

I have been a devoted member and volunteer of Optimist International since 1976. This organization serves children from around the world who are in need of an adults help and caring. In 1997, the organization asked me to come to St. Louis, Missouri, and assist in the day-to-day operations. For 18 months I served as Associate Executive Director, and on the resignation of the Executive Director, I served as Interim Executive Director until the organization could find a replacement. It was during my tenure in St. Louis that we were able to open new clubs in Russia, Rumania, Bulgaria, and several other areas of Eastern Europe.

I have been fortunate to be able to create and run businesses that have taken me from being a lawn mower repairperson to owning trucking companies, motels, and restaurants. It is due to my ownership of these companies, and now my education, that I have the ability and capacity to understand what students, as well as business owners, need in their quest to become entrepreneurs. I must point out that none of my achievements would have been possible without the help of many wonderful, hardworking employees, a wife dedicated to my dreams, and my children who went along with all of "dad's wacky ideas". Thanks to all of these wonderful people and especially my wife of 42 years, I have been a successful entrepreneur.

Teaching Philosophy

The teaching philosophy I have created through my own experience as an instructor encompasses practical skills development and participant-centered learning, all from a global perspective. I understand teaching is an honored position requiring humility and veneration. As an instructor, I work hard to be a role model for my students, as well as my fellow professors. I want my students to learn from my practical experience as a successful twenty year entrepreneur. My aim is to guide my students toward a complete learning experience by facilitating a classroom, which increases their collective understanding through active participation from all of the students. I believe all instructors share an obligation to instruct students by facilitating the development of a skill set, which will serve them in their entrepreneurial careers. By giving students the necessary tools to create those skills, instructors form a foundation upon which students can grow and prosper, ultimately leading to success. I will continue to set high standards for all of my students in the belief that challenging a bright young man or woman will advance his or her ability to learn. I will be there for them by acting as a facilitator and leading the students to their own understanding of entrepreneurship. I will guide them toward defining entrepreneurship as it relates to their own lives and provide each with a competitive advantage for their business careers. As an instructor, my job is to develop personalized learning modules, which utilize my theoretical knowledge and my practical experiences. These modules must reflect the needs of each student in the classroom. Last, I must assist my students in their proficiency of opportunity recognition as a means of ensuring their successes as they leave the confines of the university setting.
